#### **COURSE DESCRIPTION**

The course will provide a comprehensive survey and substantive understanding of the major models of couple, marriage, and family therapy.

Prerequisite: CO 603 Foundations of Marriage and Family Therapy

#### **COURSE INTEGRATION**

An examination of Biblically congruent and systemically oriented practices intended to aid individuals, couples and families in their preferred ways of relating. We will discuss husband/wife, parent/child and inter-generational relationships, from biblical, systemic and narrative perspectives. As well, we will consider family structures and cultural and societal influences on the family.

# Post-Course Assignments:

2. An exegetical and practical treatment of Ephesians 5:18-32. (If you prefer to work on a different text, please consult with the instructor). An exegesis is a "reading out" of the text's meaning. The paper will examine the text in its literary, cultural, and canonical context, paying special attention to the meanings of the words used. It will conclude with an incisive discussion of the text's meaning for today in the form of a sermon or lesson outline. In your exegetical research, be sure to consult several recently published commentaries.

Length: 2000 words

Value: 30%

- 3. A major paper on the topic, "A Biblical and Systemic Understanding of Marriage and Family." The intent of this paper is to demonstrate a comprehensive understanding of family systems theory, the biblical texts, and an integration of the ideas of these two areas. The paper should cover the following areas and follow the outline suggested below. This is only a suggested outline.
  - A. Systemic ideas
    - 1. Historical antecedents of systems theory
    - Systemic principles related to marriage and family (A distillation and summary from the various approaches indicating the essence of systems theory, especially Bowen's thinking.)
  - B. Biblical ideas
    - 1. Exegetical Survey of the biblical texts pertinent to marriage and family life, specifically the ones covered in the course, including family, marriage, and parenting.
    - 2. Biblical principles related to marriage and family (A distillation and summary of the teachings of the pertinent texts.)
  - C. Integration of Biblical and systemic ideas(A description of the points of intersections of ideas in the two fields.)

The paper will build on class lectures and will demonstrate your thinking based on reading that will produce a bibliography of at least 15 references in addition



to the recommended reading. Please include a comprehensive Table of Contents at the beginning of the paper.

Length: 2500 words on typed, double-spaced pages

# **Attendance Policy**

In order to benefit fully from a seminary education, to be good stewards of time and finances, and to be considerate of their classmates and faculty members, students must be in class at every opportunity.

## **Modular Courses**

Students are expected to attend 100 per cent of each modular for which they register. If this is impossible due to extenuating circumstances, arrangements must be made with the course professor before the first day of class. If extenuating circumstances prevent a student from attending class, a maximum of one (1) full day of class can be foregone. If additional time is missed, the student will fail the course unless they first request to withdraw from the course or move the course to an audit.

#### Online Courses

If extenuating circumstances prevent a student from attending scheduled meeting times, then up to 20% of meeting time can be foregone. Students missing scheduled meeting times should make every effort to inform the course professor prior to any time missed. If additional time is missed, the student will fail the course unless they first request to withdraw from the course or move the course to an audit.

#### Semester-Based Courses

All students missing more than two full weeks of a particular course from registration to the last day of classes will receive an automatic fail (0%). A student may appeal a course failure due to excessive absences. Successful appeals will be granted only in rare cases where all absences are clearly beyond the student's control. Appeals must be made through the Academic Appeal Process.

# Course Schedules

Classes begin at 9:00 a.m. on Monday morning and run a minimum of 30 hours through the course of the week. The schedule is determined by the course professor. Students should check the syllabus for specifics. When the syllabus does not state class times, students are responsible to check with the professor prior to making travel plans.

## Assignment Submission

All assignments must be submitted no later than eight weeks after the last day of class as stated in the syllabus. The correct due dates will be clearly noted in the syllabus and each faculty member will state in their syllabus how assignments should be submitted. Assignments submitted within a week
